



Over 80's Grant Application

1. This Trust has funds available to assist **owners aged 80 years and over** who reside in New Zealand.
2. The grant will be payable on an annual basis – i.e. once every 12 months.
3. Applicants must re-apply each year.
4. **Eligibility for Grants**
Applicants must be owners of land vested in the Trust. The blocks administered by this Trust are:
 - Kaimanawa 1F, 2B
 - Runanga 2C2A, 2C3B1, 2C3B2B, 2C3C, 2A, 2B, 2C1A, 2C1B, 2C1C, 2C1D
 - Tapapa 3A, 3B1, 3B2
 - Wharetoto 1, 2A, 2B, 3, 11

Your name as owner must be shown in the application, as it is on the Maori Land Court ownership list which can be checked at www.maorilandonline.govt.nz.

If the current registered owner is a Whanau Trust, the Secretary or a Trustee of the Whanau Trust must complete the Ownership by Whanau Trust page. If the applicant is in doubt in these regards, please get confirmation of ownership from the Maori Land Court.

5. Applicants must provide a copy of their Birth Certificate OR Passport OR New Zealand Drivers Licence OR New Zealand Firearms Licence.
6. If applicants have previously had an Over 80s Grant approved by this Trust and are re-applying for a Grant, they do not have to send in ownership details or birth identification with subsequent applications.
7. Grants will be paid into the nominated bank account provided in the application form.
